Reference Guide: Federal Terminations and Stop Work Orders

This guide is designed to provide Yale Principal Investigators (PIs) and Department Business Offices (DBOs)/support units with high-level instructions for managing sponsored awards when notified of an award termination or a stop work order (SWO).

Terminated Awards: Final Financial Reporting (FFR) Due Dates Guide

Guide covers the time between an award's official termination date and its final financial report (FFR) or invoice varies by award. To meet sponsor requirements, it is crucial to adhere to all appropriate reviews and reconciliations. SPFA will cover agency due dates and Yale policy on final submission due dates.

Non-Cancellable Commitments (NCC) and Orderly Closeout Charges (OCC) Form

This document should be used as guidance whenever a Principal Investigator (PI) receives an award termination or Stop Work order (SWO) and final reconciliations are underway. Guide covers Non-Cancellable Commitments (NCC) and Orderly Closeout Costs (OCC) during final financial reporting.

Rescinded/Reinstated Award Guidance Document

A recission is a positive result of an appeal, court order or agency decision, but there are very specific and often complex steps that need to be taken to reinstate the grant. Action will depend on the details of your original grant and the terms of the reinstatement. Here's a general guide to what you should do.
